RECOMMENDED That Council:

- (a) Approves the proposed Revenue and Capital Budgets for 2025/26 including a Council Tax rate of £239.76 at Band D, representing a £6.94 increase (2.99%) on the current charge.
- (b) Agrees the Medium Term Financial Strategy, Capital Strategy, Treasury Management Strategy and Prudential Indicators
- (c) Agrees the Fees & Charges Schedule for 2025/26.
- (d) Council Tax Resolution
- 1 That it be noted that (on 31st January, 2025) the Chief Finance Officer calculated the Council Tax Base 2025/26 for the whole Council area as **43,147.4** [Item T in the formula in Section 31B(1) of the Local Government Finance Act 1992, as amended, (the "Act")] and that this Council Tax base be split between the regions of the Environment Agency as follows:

Southern - 43,147.4

- 2 That the following amounts be calculated by the Council for the year 2025/26 in accordance with Sections 31 and 34 to 36 of the Act.
 - (i) £ 66,550,393 (expenditure) being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act;
 - (ii) £56,205,372 (income) being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act;
 - (iii) £10,345,021 being the amount by which the aggregate at d(i) above exceeds the aggregate at d(ii) above, calculated by the Council, in accordance with Section 31A(4) of the Act, as its Council Tax requirement for the year (Item R in the formula in section 31A(4) of the Act);
 - (iv) £239.76 being the amount at c(iii) above (Item R), divided by Item T (b above), calculated by the Council, in accordance with Section 31B(1) of the Act, as the basic amount of its Council Tax for the year;
